Cady School (Girls Unit) and may also be required to work at the Boys Unit. The Girls Unit is located at 915 River Road, Middletown, CT 06457. These are permanent full-time (35 hours per week) positions. Qualified candidates must possess a valid CT Teaching Certificate in any core academic subject (math, science English, social studies), Special Education (165) is preferred. Additionally, the ideal candidate will be resourceful, creative, have a working knowledge of the CT Curriculum Frameworks, strong classroom management skills, and a repertoire of varied individualized and small group instructional techniques. Experience in an educational program within a residential treatment facility and experience with a culturally diverse student population is preferred in addition to familiarity with gender specific programming. The DCF Girls secure Unit will be a short term rapid reintegration unit for girls in need of brief stabilization. It will respond to the needs of the congregate care programs and will also be some emergency bed capacities.

Knowledge, Skills and Abilities:

Knowledge of the philosophy and methods of education and teaching; knowledge of the principles and practices of education for special needs population; knowledge of student program needs and goal setting; ability to motivate students; ability to communicate at the appropriate level; ability to establish cooperative relationships with those contacted in work; ability to prepare written reports.

General Experience: Possession of a Bachelor's degree from an accredited university or college. Valid CT Teaching Certification is required, with a preference for those with certification in Special Education (165).
