General Experience: A current license as an advanced practice registered nurse issued by the Connecticut Department of Public Health.

Special Requirement: Must possess and retain a current/valid Motor Vehicle Operator's License. May be required to travel.

Duties: This Advanced Nurse Practitioner will provide advanced practice psychiatric nursing services in an outpatient setting to clients with behavioral health and substance use disorders. As a member of a multidisciplinary treatment team: provides initial psychiatric assessment, ongoing mental status examination, ordering and review of medical tests, and the prescribing of appropriate medications consistent with client's diagnosis and symptom presentation. Participate in collaboration of services with community providers. Participate in education and training activities to be able to further professional development that relates to the programming needs of the agency. This position may provide clinical and administrative supervision of RN's, LPN's as assigned by the Medical Director and Site Director. This APRN will work with a Principal Psychiatrist as collaborator per DMHAS protocol.

Note: The filling of this position will be in accordance with reemployment, SEBAC, transfer, promotion and merit employment rules, if applicable.

3. **All Other Candidates:** Individuals must complete a State Employment Application for Examination and Employment (CT-HR-12). Resumes and Curriculum Vitae can be provided as supplemental information but will only be accepted if attached to a fully completed application. The position number must be noted at the bottom of Page One of the State of Connecticut Application (CT-HR-12).
