Eligibility Requirement: State employees currently holding the above title or those who have previously attained permanent status or candidates who possess the general and special experience and training may apply.

Duties may include but not limited to: Provides direct care psychiatric services to young adult clients at WCMHN-Danbury Area Office. Provides administrative and supervisory functions as a board certified physician. Responsible for assigned case load including 24/7 coverage. Participates as a member of multidisciplinary treatment team. Responsible for reviewing treatment plans, clinical records, and client discharge plans in adherence to WCMHN policies and procedures. May participate in meetings on clinical and administrative issues. Responsible for examining clients for admission and discharge. Responsible for assessing, diagnosing and prescribing appropriate medications and treatments for clients with psychiatric illnesses and substance abuse disorders. Performs advanced risk assessments, consults on difficult cases, collaborates with medical providers in the community as well as other community providers.

General Experience: Incumbents in this class must possess and retain certification as a specialist in psychiatry by the American Board of Psychiatry and Neurology or board certification in Adult or Child and Adolescent Psychiatry.

Special Requirements:

1. Incumbents in this class must possess and retain a license to practice medicine and surgery in Connecticut. A temporary license may be granted for a period not to exceed one (1) year.
2. Incumbents in this class must possess and maintain eligibility for participation in federal health care programs as defined in 42 U.S. 1320a-7b(f).

Note: The filling of this position will be in accordance with reemployment, SEBAC, transfer, promotion and merit employment rules, if applicable.

To be considered for this position:

2. **DMHAS employees who are promotion/demotion candidates** must submit pages 1-7 of the State of Connecticut Application for Examination and Employment (CT-HR-12). The position number must be noted at the bottom of Page One of the State of Connecticut Application (CT-HR-12).
3. **All Other Candidates:** Individuals must complete a State Employment Application for Examination and Employment (CT-HR-12). Resumes and Curriculum Vitae can be provided as supplemental information but will only be accepted if attached to a fully completed application. The position number must be noted at the bottom of Page One of the State of Connecticut Application (CT-HR-12).
