- Minimum Qualifications:** Master's Degree in Mathematics or a closely related discipline with an emphasis on coursework in advanced mathematics.
The successful candidate must demonstrate:
- A passion for teaching mathematics to both majors and non-majors, both well prepared and marginally prepared students, at the community college level;
 - Ability to develop and teach mathematics courses (quantitative reasoning to differential equations) both face-to-face and online using effective teaching techniques and technology to address the needs of a diverse student body with an array of learning styles;
 - Competency in exploring, implementing, documenting, and objectively evaluating and assessing student learning, engagement and experimental teaching approaches;
 - Excellent teaching, communication and interpersonal skills;
 - Evidence of strong skills and abilities in program and curriculum development, classroom strategies, and academic advising; and
 - Understanding of the needs of the community college student and have a track record of effectiveness and capability in working with a diverse population.
- Preferred Qualifications:** Two years of experience teaching college-level mathematics courses (with excellent classroom and student evaluations) at the community college level; experience designing and implementing creative mathematical curricula and lessons; and professional experience as a mathematician in a non-academic setting.
- General Responsibilities:** This instructor is expected to teach twenty-four credit hours each academic year in the area of mathematics, plus additional responsibilities as governed by the collective bargaining contract. S/he will also be responsible for implementation and evaluation of innovative mathematics curricula. Student support, motivation, retention and successful learning are important responsibilities. Other responsibilities include: course, program, and curriculum development; development of new instructional techniques; student advising; development of and participation in special college projects; and participation in departmental, college, and community service activities consistent with the mission of the College. This instructor is also required to participate in commencement and convocation activities as well as special college meetings. The teaching schedule may include evenings and/or weekends in a face to face and/or online teaching environment.
