Duties may include but not limited to: Reports directly to the Hospital Services Division Director of Nursing 2 and will be responsible for the administrative supervisory oversight of PICU 2. The duties include but are not limited to coordinating, managing and overseeing the entire PICU 2 program. The Director of Nursing 1 will be responsible for creating, coordinating and maintaining the program group process and treatment planning process. This position is responsible for maintaining a safe, therapeutic and recovery-focused program that delivers safe high quality client care. The Director of Nursing 1 will be part of Hospital Services Division leadership and will be expected to participate in SWCMHC/GBCMHC committees as needed. Also responsible for ensuring compliance with the Joint Commission on Accreditation of Healthcare Organization (JCAHO) and the Centers for Medicare and Medicaid Services (CMS), and performs other duties as assigned.

General Experience: Two (2) years of experience in hospital nursing in a managerial or supervisory capacity at or above the level of Supervising Nurse working with the patients/clients serviced by the agency.

Special Requirement: Incumbents in this class may be required to possess and retain a license as a registered professional nurse in Connecticut. Must possess, retain, and carry valid Motor Vehicle Operator's License. Travel in the community is required.

Eligibility Requirement: State employees currently holding the above title or those who have previously attained permanent status or candidates who possess the general and special experience and training may apply.

Note: Applicants will be selected in accordance with reemployment, SEBAC, transfer, promotion, collective bargaining unit contract language, merit employment lists and DMHAS affirmative action goals. Therefore, State employees will generally be considered before applicants from outside State service.
