General Experience: One year of experience as a licensed clinical social worker.

Special Requirements:

1. Incumbents in this class must possess and retain a license to practice clinical social work pursuant to Sec. 20-195 (m) through (r) of the Connecticut General Statutes.
2. Must possess and retain a current/valid Motor Vehicle Operator's License. May be required to travel.

DUTIES: Member of an interdisciplinary team who is responsible for performing psychiatric evaluations and crisis interventions in the community, local emergency rooms, and other agencies. Provides coverage for the crisis hotline, with ability to access resources to people who request information and data entry as required. Provides intake services to the greater Torrington region. Acts as a backup to the jail diversion program by providing liaison, assessments, and consultations in the court. Provides supervision to the intake team when the intake supervisor is off site. Provides clinical supervision of assigned MSW staff, students, and/or interns preparing for licensure.

Working Conditions: Incumbents in the class may be exposed to some risk of injury from assaultive and/or abusive clients.

Note: The filling of this position will be in accordance with reemployment, SEBAC, transfer, promotion and merit employment rules, if applicable.
