**Duties may include but not limited to:** Will work as a member of an ambulatory multi-disciplinary treatment team; independently developing comprehensive psychosocial assessments through interviews with assigned clients and families. Assessments will include consideration of developmental, social and cultural factors, substance use, as well as psychological, environmental and medical issues. Will provide individual, family and group treatment. Will possess competence in evidence-based practices, including, but not limited to, Dialectical Behavior Therapy, Integrated Dual Diagnosis Treatment and Illness Management and Recovery. Will develop crisis response plans and manage crises as needed. Will be responsible for the development of recovery-oriented treatment plans that include measurable treatment goals and objectives. Will monitor and evaluate the effectiveness of treatment plans. Will consult and collaborate with other behavioral health and community service providers to improve and coordinate delivery of services to clients. Will document treatment in clinical records and complete clinical reports in compliance with agency and accrediting bodies. May provide forensic evaluations and court testimony as required. May provide field work instruction and/or clinical supervision to clinical staff of lower grade. . May participate in facility or community-based committees. May perform related duties as required.

**General Experience and Training:** Licensure as a clinical social worker in the State of Connecticut.

**Special Requirements:** Must possess and retain a current motor vehicle operator's license. Travel required. Incumbents in this class must possess and retain a license to practice clinical social work pursuant to Sec. 20-195 (m) through (r) of the Connecticut General Statutes.

**Eligibility Requirement:** State employees currently holding the above title or those who have previously attained permanent status or candidates who possess the general and special experience and training may apply.

**Note:** This position is temporary. The temporary assignment is needed. The position can expire or when the incumbent returns, or if there is no longer a need for the position. There is no guarantee of a permanent position. Benefits and leave accruals/holidays will be in accordance with bargaining unit contract language and Connecticut General Statutes.

Applicants will be selected in accordance with reemployment, SEBAC, transfer, promotion, collective bargaining unit contract language, merit employment lists and DMHAS affirmative action goals. Therefore, State employees will generally be considered before applicants from outside State service.

**To be considered for this position:**

1. **DMHAS employees who are lateral transfer candidates** (example: CSW applying to a CSW posting) must submit a completed DMHAS Lateral Transfer Form. Lateral Transfer Request Forms received without a position number will not be processed
2. **DMHAS employees who are promotional/demotional candidates** must submit the State of Connecticut Application for Examination and Employment (CT-HR-12). The position number must be noted at the bottom of Page One of the State of Connecticut Application (CT-HR-12).
3. **All other applicants** must complete a State Employment Application for Examination and Employment (CT-HR-12). Resumes and Curriculum Vitae can be provided as supplemental information but will only be accepted if attached to a fully completed application.
