The Connecticut Insurance Department is recruiting for an Insurance Certified Financial Examiner position for the Financial Analysis and Compliance Unit in the Financial Regulation Division. This position will supervise and review the financial analysis work of lower level insurance examiners; provides assistance regarding procedures and techniques; oversees the analysis activities of the following reports: annual and quarterly financial statements, actuarial opinion and summary, Management's Discussion and Analysis, Audited Financial Statements, Holding Company Filings, Corporate Governance, Own Risk Solvency Analysis, financial ratios and NAIC financial solvency tools; assists in determining areas to be further examined by the field examiners; may conduct financial examinations as needed and will perform related duties as required. ***This position requires a Certified Financial Examiner (CFE) designation or Certified Public Accountant (CPA) certification.**

Knowledge, Skills and Abilities: Considerable knowledge of relevant agency policies and procedures; considerable knowledge of and ability to apply relevant state and federal laws, statutes and regulations; considerable knowledge of accounting and auditing principles and practices involved in the examination of insurance companies; considerable knowledge of the organization and business practices of insurance companies; considerable ability to analyze and evaluate insurance company financial statements and reports by Certified Public Accountants, actuaries and consultants; considerable interpersonal skills; considerable oral and written communication skills; some supervisory ability; ability to utilize computer software.

Preferred skills:

- Considerable knowledge of statutory accounting and examination practices;
- Supervisory skills;
- Knowledge of relevant agency policies and procedures;
- Considerable knowledge of relevant statutes and regulations;
- Interpersonal and communication skills.

General Experience:

Eight (8) years of experience in one or more of the following areas: regulatory examination of financial condition or market conduct of insurance companies; accounting, auditing or actuarial work in the insurance industry.

Special Experience:

One (1) year of the General Experience must have been in an advanced working level or consultative capacity in professional work in insurance examining or auditing.

Substitution Allowed:

1. College training in Accounting, Insurance, Business, Finance, Actuarial Science or Economics may be substituted for the General Experience on the basis of fifteen (15) semester hours equaling one-half (1/2) year of experience to a maximum of four (4) years for a Bachelor's degree.
2. A Master's degree in Accounting, Insurance, Business, Finance or Economics may be substituted for an additional year of the General Experience.
3. Certification in any of the following may be substituted for one (1) additional year of the General Experience: Certified Public Accountant, Certified Internal Auditor.

Special Requirements: *

1. Incumbents must possess at time of appointment and maintain during employment the designation of Certified Financial Examiner (CFE) or Certified Public Accountant (CPA).
2. Incumbents in this class may be required to travel.
3. Incumbents in this class may be required to possess and retain a valid Motor Vehicle Operator's license.

Note: The filling of this position will be in accordance with reemployment, SEBAC, transfer, promotion and merit employment rules, if applicable.
