**Duties may include but not limited to:** The Advanced Nurse Practitioner will provide initial psychiatric evaluation, ongoing mental status examination, ordering & review of medical tests, and the prescribing of appropriate medications consistent with client's diagnosis and symptom presentation. Provide individual, family and group counseling as needed. Will participate in collaboration of services with community providers as needed. Participate in education and training activities to be able to further professional development that relates to the programming needs of the unit. Assist with programming choices based on a person centered choice and recovery approach. This position may provide clinical and administrative supervision of the RN', social worker, community clinician, mental health worker and other staff as assigned by the Medical Director. The position will work with a Principal Psychiatrist as collaborator per DMHAS protocol. Will be assigned to the Medical Services Unit and functional unit assignment will be subject to the needs of the agency. Will be expected to participate in leadership roles, in particularly as regards to agency Nurse Clinicians & Head Nurses.

**General Experience:** A current license as an advanced practice registered nurse issued by the Connecticut Department of Public Health.

**Special Requirement:** Must possess, retain, and carry valid Connecticut Drivers License. Travel in the community is required.

**Eligibility Requirement:** State employees currently holding the above title or those who have previously attained permanent status or candidates who possess the general and special experience and training may apply.

**Note:** Applicants will be selected in accordance with reemployment, SEBAC, transfer, promotion, collective bargaining unit contract language, merit employment lists and DMHAS affirmative action goals. Therefore, State employees will generally be considered before applicants from outside State service.
