Duties include: monitoring and providing consultation to assigned programs, including oversight of the transitions of young adults from the DCF system of care to DMHAS YAS; responsible for oversight of service plan development, coordination, compliance, and consultation to programs and triaging of clients for placement; provide oversight of program budgets, program development initiatives, and outcome measures; interface with DCF and instate and out of state program staff to ensure effective transitions and monitor ongoing placements and programming. This position is critical to public health, welfare, and safety due to the type and severity of dysfunction of the clients that these programs are serving. This position will also require travel to in state and out of state locations to meet with staff and clients, review program policies and procedures and tour the facilities.

General Experience:

Four (4) years of professional experience in Behavioral Health Care and a Master Degree in a clinical discipline, Public Health Administration, Health Care Administration or Hospital Administration.

Special Experience:

Two (2) years of the General Experience must have been supervising professional staff.

For state employees, this is at the level of Behavioral Health Unit Supervisor; Nurse Supervisor or Supervising Clinician.

Special Requirements: Incumbents in this class must maintain the appropriate current license for clinical social work, or clinical psychologist. Incumbent will be required to travel and must have a valid motor vehicle operator's license.
