Duties may include but not limited to: Provide nursing coverage for the Behavioral Health Home project at CRMHC. Work under direction of staff of higher grade, coordinating care, client appointments; liaison with community primary care providers and specialists for clients identified by DSS as having severe medical and psychiatric comorbidity, provides client education, direct nursing care to clients, document interventions in electronic medical record. Provide nursing coverage to Forensic and Young Adult Services team, checking medication orders, administering medications as needed, consulting on client medical issues and concerns; Assists BHH physician in managing appointments; assists with obtaining patient history and physical exams; coordinates care for designated clients with primary care providers in the community. Performs other related duties as assigned.

Eligibility Requirement: State employees currently holding the above title or those who have previously attained permanent status may apply for lateral transfer.

General Experience: Graduation from an accredited nursing program.

Special Requirement: Incumbents in this class must possess and retain a license or temporary permit as a Registered Professional Nurse in Connecticut. Incumbents in this class may be required to travel.

Working Conditions: Incumbents in this class may be required to lift and restrain patients/clients; may have exposure to communicable/infectious diseases and risk of injury from assaultive/abusive patients/clients; may be exposed to disagreeable conditions.

Note: The filling of this position will be in accordance with reemployment, SEBAC, transfer, promotion and merit employment rules, if applicable.

To be considered for this position:
