Duties: Preferred applicants will have experience with counseling and advising residents with behavior problems, progress in unit and placement plans; participating in maintaining a therapeutic milieu by meeting psychological and physical needs of residents; overseeing daily living activities to insure proper care of residents; teaching residents in unit self support skills such as basic money management, daily living habits, hygiene, etc.; promoting positive behaviors through a community ownership program; overseeing recreational activities for residents; writing reports of significant events in unit such as runaways and accidents; checking temperatures of residents and dispensing selected medications; recording daily activities in log book; escorting residents to destinations on and off grounds, to and from meals, class, infirmary, court, placements, etc; disciplining children who are acting out and following up with appropriate action; attending staff meetings and training sessions to improve treatment and therapy skills; performing related duties as required.

General Experience: Two (2) years of paraprofessional experience in an applied treatment program for emotionally disturbed, delinquent, behaviorally disordered, educationally deficient or mentally retarded children or youth.

Substitution Allowed: an Associate's Degree in the health, human services or mental health areas may be substituted for the general experience. Thirty (30) college credits in a course of study leading to a Bachelor's Degree in the behavioral sciences may be substituted for one (1) year of the general experience.

Working Conditions: Incumbents in this class may be required to lift or restrain residents and may have significant exposure to risk or injury from assaultive and/or abusive residents.
