Eligibility Requirement: The Department of Children and Families currently has vacancies for Full Time, 40 hours per week, Youth Services Officer positions at the Connecticut Juvenile Training School. Schedule Hours: 2nd Shift: 9 days per pay period, every other weekend on duty. Hours are 2:15 p.m. - 11:08 p.m. Applicants with a degree or experience in Criminal Justice are strongly encouraged to apply.

Knowledge, Skills and Abilities: Knowledge of principles and practices involved in care, custody and rehabilitative guidance of delinquent youth; knowledge of behavioral and emotional problems experienced by youth; basic knowledge of policies, procedures and philosophies of Connecticut Juvenile Training School; considerable interpersonal skills; oral and written communication skills; ability to supervise residents and counsel when necessary; ability to prepare reports.

General Experience: One (1) year of paraprofessional experience working with persons with emotional disturbances, behavioral disorders, educational deficiencies or developmental disabilities.

Substitution Allowed: (from the Class Specification)

- 1) An Associate's Degree in the behavioral sciences, criminal justice or human services may be substituted for the General Experience.
- 2) Fifteen (15) college credits in a course of study leading to a Bachelor's Degree in a behavioral science, criminal justice or a human service area may be substituted for six months of the General Experience.
- 3) For State employees, one (1) year of experience as a Youth Services Officer Trainee may be substituted for the General Experience.

Special Requirement: Incumbents in this class may be required to travel.

Working Conditions: Incumbents in this class may be required to physically restrain residents, may have some exposure to infectious and/or communicable diseases and may be exposed to some danger of injury from assaultive and/or abusive residents.
