Eligibility Requirement: Candidates who possess the general and special experience and training may apply.

Duties may include not limited to: The Clinical Nurse Coordinators assigned to the CMHC Behavioral Health Home will work under the supervision of the Behavioral Health Home Director, and will be responsible for the provision of Behavioral Health Home (BHH) services to an adult outpatient population with serious and persistent behavioral health disorders and co-occurring medical conditions. Services will include comprehensive care management, care coordination, health promotion, transitional care, individual and family support services and referral to community services. Will participate in the development of care plans for all BHH enrollees; assisting in the setting of goals related to the management of acute and chronic health conditions. Will coordinate with clinical teams regarding specific client health issues. Will collaborate with other medical professionals, especially during enrollee admission or discharge from other services. Will participate in the development of training protocols on chronic health conditions and facilitate other health promotion, wellness and prevention initiatives. Will facilitate health education groups. Will perform and track required health screenings and assessments. Will monitor and report on required BHH goals and outcomes. Will perform other related duties as assigned. The successful applicants will have significant experience working in an adult behavioral health setting and will demonstrate an ability to support clients in achieving recovery goals related to improving their physical health and well-being.

General Experience: Three (3) years of professional nursing experience.

Special Experience: One (1) year of the General Experience must have been at the level of Head Nurse working with the type of clients indicated by the parenthetical title.

Substitutions Allowed:

1. A Bachelor's degree in nursing may be substituted for one (1) year of the General Experience.
2. A Master's degree in nursing may be substituted for one (1) additional year of the General Experience.

Special Requirements:

1. Incumbents in this class must possess and retain a license as a registered nurse in Connecticut.
2. Must possess and retain a current/valid Motor Vehicle Operator's License. Incumbents in this class may be required to travel.
