Duties include but are not limited to: The clinical social worker will serve on an interdisciplinary clinical team specializing in community mental health treatment and rehabilitation; Responsibilities include diagnosis, psychosocial assessments, recovery planning, referral, crisis intervention, individual and group psychotherapy and outreach; Collaboration with other DMHAS units and non-DMHAS providers; Will participate in organizational committees and trainings as directed and other duties as required.

General Experience and Training: Licensure as a clinical social worker in the State of Connecticut.

Special Requirement: Incumbents in this class must possess and retain a license to practice clinical social work pursuant to Sec. 20-195 (m) through (r) of the Connecticut General Statutes. Must possess, retain and carry a valid Connecticut Driver's License. Travel in the community is required.
