Eligibility Requirement:

The Department of Children and Families has a vacancy at the Albert J. Solnit Children's Psychiatric Center South Campus (formerly Riverview Hospital) for a Psychologist (Clinical). This is a part-time (34 hours per week) position on the Sachem/Passaic Units with primary coverage on the Sachem Unit. This position will work as part of a multi-disciplinary team and is accountable for skilled clinical care and psychological testing of youth with complex behavioral health needs. This position may be underfilled at the level of Postdoctoral Fellow - Psychology Department (Clinical).

Knowledge, Skills and Abilities: Considerable knowledge of abnormal and clinical psychology; considerable knowledge and skill in selection, administration, scoring, and evaluation of intelligence, achievement, personality, and diagnostic tests; considerable knowledge of psychological research methodology including experimental design, data analysis, and application of findings, knowledge of other psychological disciplines; considerable interpersonal skills; considerable oral and written communication skills; considerable ability to make clinical diagnosis and prognosis and develop treatment plans; considerable ability to conduct psychotherapy; considerable ability to write case histories, discharge summaries, and professional reports; ability to coordinate clinical services with comprehensive and multidisciplinary treatment teams.

General Experience: A doctorate degree in clinical psychology and one (1) year post doctoral experience as a psychologist working under the supervision of a licensed psychologist is required.

Special Requirement: Incumbents in this class must possess and retain a license to practice psychologist in Connecticut.

Working Conditions: Incumbents in this class may be required to lift and restrain patients/clients, may have some exposure to communicable/infectious diseases and to risk of injury from assaultive/abusive patients/clients; may be exposed to disagreeable conditions.

Note: The filling of this position will be in accordance with reemployment, SEBAC, transfer, promotion and merit employment rules, if applicable.
