The Unified School District #2 of the Department of Children and Families has an anticipated employment opportunity for one (1) 35 hour, 12-month state school teacher position. This position is located at the South Campus of the Albert J. Solnit Children's Psychiatric Center in Middletown, CT, a school operated within a psychiatric facility for children and youth. This position requires a certification in Home Economics (PK-12), specifically #045. An additional certification in special education is preferred. Experience in an educational program within a residential treatment facility and experience with a culturally diverse student population is also preferred. Responsibilities include, but are not limited to: the planning for and direct instruction of students, participation in planning and placement team (PPT) meetings, conducting student assessments, and implementing curriculum which is aligned with CT's Curriculum Frameworks. Additional duties include participating in treatment team conferences, assessing and managing student behavior; maintaining student academic records and evaluating student progress.

Possession of a Bachelor's degree from an accredited university or college.
