Applicants should be knowledgeable in principles and practices of dental operative techniques and minor dental surgery; must possess interpersonal skills needed to manage young adolescents and young adults with conduct disordered behaviors and/or psychiatric disorders; a candidate with computer skills is preferred to maintain dental records and dental scheduling. The dentist is responsible for providing preventive dental maintenance and acute dental care including oral examinations and diagnoses, operative and prosthetic dentistry, exodontia, periodontia, radiology and prophylaxis; administering medication; responding to dental emergencies; educating clients and staff on importance of good oral health; and supervision of dental staff.
