Examples of Duties: Nursing responsibilities are consistent with Clinical Nurse Coordinator job specifications. Provide oversight and coordination of health care needs/services for individuals residing in DDS licensed and ICF (Intermediate Care Facility) certified programs or IHS (Individual Home Support) programs. Delegate medication administration and medical treatments to licensed nurses and non-licensed certified staff. Implement med sanction process. Train/retrain non-licensed staff. Develop and implement plans for continuing care; ensure nursing directives and physician's orders are carried out in a complete and timely manner. Maintain records and provide written reports. Provide nursing services that comply with ICF regulation, DDS policy and regulation and RN Quality Job Performance Standards. Provide nursing input and medical information to interdisciplinary team. Complete and update nursing summaries. Complete infection control and medication reviews. Attend CNC and IDT meetings. Collaborate with community agencies. On-call on a rotating basis. Performs related duties as required. BLS and current driver's license. Must possess good writing and communication skills. Computer proficient. Prefer one (1) year of the General Experience to include working with individuals with developmental disabilities.

Minimum Qualifications Required

Knowledge, Skill And Ability: Knowledge of individual treatment planning, including impact of medical insurance program requirements for reimbursement; knowledge of structure of services for clients and their families in institutional and community-oriented settings as related to parenthetical title; knowledge of aftercare facilities; considerable interpersonal skills; oral and written communication skills. Knowledge of nursing principles and clinical therapeutic models of patient and/or client care with emphasis on interdisciplinary team approaches as related to individuals with developmental disabilities.

General Experience: Three (3) years of professional nursing experience.

Special Experience: One (1) year of the General Experience must have been at the level of Head Nurse working with individuals with developmental disabilities.

Department of Developmental Services (General): One (1) year of the General Experience must have been providing consultation and evaluating the assessment of nursing services provided to individuals with intellectual disabilities.

Substitutions Allowed: A Bachelor's degree in nursing may be substituted for one (1) year of the General Experience. A Master's degree in nursing may be substituted for one (1) additional year of the General Experience.

Special Requirement: Incumbents in this class must possess and retain a license as a registered nurse in Connecticut. Incumbents in this class may be required to travel.

Note: The filling of this position will be in accordance with reemployment, SEBAC, transfer, promotion and merit employment rules, if applicable.
