Eligibility Requirement: Candidates on Reemployment/SEBAC lists will be given first consideration.

Description of Duties:

- Perform highly skilled tasks on DEEP plumbing and heating systems, gas, water, steam and sewer disposal systems.
- Maintenance and repairs to public restroom facilities include valve, fixture, piping, flush-o-meter, fixture and sewer line repair/replacement.
- Conduct annual winterization and startups of seasonal buildings.
- Perform public water system testing and other requires repaired to meet DPH standards.
- Installation, maintenance and repair to oil and gas burners and associated equipment.
- Installation and repairs to well pumps, tanks, and related controls.

Preferred Candidate Must Have:

- Excellent knowledge of standard plumbing and heating trade practices including materials, operation, equipment and repair methods.
- Must have an Unlimited Journeymen's license in plumbing or heating related field.
- Good experience and possession of license, and/or certifications relating to the installation, maintenance and repair to oil burners and other heating related equipment.
- Good interpersonal, oral and written communication skills.
- Basic computer and estimating skills.
- Good records keeping experience.

General Experience:

Four (4) years of experience in plumbing and heating.

Special Experience:

Two (2) years of general experience must have been performing skilled trade functions and having a P-2 or S-2 license.

Substitutions Allowed:

- 1) Graduation from a vocational or technical school with a diploma designating completion of subject requirements in a maintenance trade area may be substituted for two (2) years of the general experience.

2) Two (2) years of experience as a Qualified Craft Worker Intern may be substituted for the General and Special Experience.

Special Requirement:

- Incumbents in this class will be required by the appointing authority to possess and retain appropriate current licenses, permits and/or certifications including possession and retention of an Unlimited Journeymen's license in the plumbing field.
- Incumbents in this class must have adequate physical strength, stamina, physical agility and visual and auditory acuity and must maintain such physical fitness as to be able to perform the duties. A physical examination may be required.
- Incumbents in this class may be required to lift moderate to heavy weight and may be exposed to extreme weather conditions and to risk of injury from equipment.
- Incumbents in this class may be required to possess and retain specific education and/or experience to meet various certification requirements.
- Incumbents in this class may be required to possess and retain specific education and/or experience to meet various certification requirements.
- Required to use appropriate protective equipment such as respirators and safety goggles.
- Incumbent in this class may be required to travel.
