Duties include but are not limited to: The licensed clinical social worker will serve on an interdisciplinary clinical team specializing in intake and assessment of clients in need of services and/or referral to community programs. Responsibilities include diagnosis, psychosocial assessments, recovery planning, referral to DMHAS outpatient providers or appropriate community agencies, crisis intervention, individual brief treatment and outreach, collaboration with other DMHAS units and non-DMHAS providers; may participate in organizational committees and trainings as directed and other duties as required.

General Experience and Training: Licensure as a clinical social worker in the State of Connecticut.

Special Requirement: Incumbents in this class must possess and retain a license to practice clinical social work pursuant to Sec. 20-195 (m) through (r) of the Connecticut General Statutes. Must possess, retain and carry valid Motor Vehicle Operator's License. Travel in the community is required. Bilingual Spanish preferred.

Note: The filling of this position will be in accordance with reemployment, SEBAC, transfer, promotion and merit employment rules, if applicable.

To be considered for this position:

1. **DMHAS employees who are lateral transfer candidates** (example: Clinical Social Worker applying to a Clinical Social Worker posting) must submit a completed DMHAS Lateral Transfer Form. Lateral Transfer Request Forms received without a position number will not be processed
2. **DMHAS employees who are promotional/demotional candidates** must submit the State of Connecticut Application for Examination and Employment (CT-HR-12). The position number must be noted at the bottom of Page One of the State of Connecticut Application (CT-HR-12).
3. **All other applicants** must complete a State Employment Application for Examination and Employment (CT-HR-12). Resumes and Curriculum Vitae can be provided as supplemental information but will only be accepted if attached to a fully completed application. All applicants must submit three (3) letters of supervisory reference, a copy of any license or certification and their two most recent performance appraisals.
