Eligibility Requirement: State employees who possess the general and special experience and training may apply. State employees currently holding the above title or those who have previously attained permanent status may apply. DMHAS employees currently holding the above title may apply for lateral transfer.

Duties may include but not limited to: Successful candidate will work as part of a multidisciplinary team providing direct care to individuals with severe and persistent mental illness and substance use disorders. The psychiatrist will provide ongoing assessment and treatment in conjunction with a team comprised of RNs, LCSWs, mental health workers and other support staff. Much of the time will be spent in the community and may include evaluations of clients in ERs and hospitals or other outpatient settings. The psychiatrist will participate in monitoring delivery of health care services; will consult with clinical staff regarding assessment methods and treatment plans; provide direction to staff on appropriate health record documentation; function as liaison between agency and community health care providers; participate in professional practice committees, clinical leadership and other clinical committees as needed; monitor quality assurance in accordance with Joint Commission standards. May assist families and other groups in understanding psychiatric and medical needs of clients served by the agency; may provide training and supervision to nursing and paraprofessional staff; prescribe medications and may administer medications, make and follow up on referrals, conduct client centered conferences, provide counseling and education to clients and families. Other duties may include supervision of APRNs or allocating some time for our out-patient department, utilizing an electronic medical records system and other related duties as assigned. Voluntary on-call coverage and weekend coverage is available at additional reimbursement.

For Principal Psychiatrist: General Experience: Incumbents in this class must possess and retain certification as a specialist in psychiatry by the American Board of Psychiatry and Neurology or board certification in Adult or Child and Adolescent Psychiatry.

Special Requirements: Incumbents in this class must possess and retain a license to practice medicine and surgery in Connecticut. A temporary license may be granted for a period not to exceed one (1) year. Incumbents in this class must possess and maintain eligibility for participation in federal health care programs as defined in 42 U.S. 1320-7b(f). Incumbents in this class may be required to possess and retain certification as a specialist in an area such as geriatrics, ABI/TBI, forensics, substance abuse, etc. Incumbents in this class may be required to possess appropriate current licenses, certifications or permits. Incumbents in this class must possess and retain a valid driver's license and may be required to travel.

For Staff Psychiatrist: General Experience: Graduation from an Accredited Council of Graduate Medical Education (ACGME) psychiatric residency program.

Special Requirements: Incumbents in this class must possess and retain a license to practice medicine and surgery in Connecticut. A temporary license may be granted for a period not to exceed one (1) year. Incumbents in this class must obtain certification as a specialist in psychiatry by the American Board of Psychiatry and Neurology within five years of appointment to this class OR demonstrate continued competency and proficiency in the practice of psychiatry by successfully completing an established agency program. Incumbents in this class must possess and maintain eligibility for participation in federal health care programs as defined in 42 U.S. 1320-7b(f). Incumbents in this class may be required to possess appropriate current licenses, certifications or permits. Incumbents in this class must possess and retain a valid driver's license and may be required to travel.

Note: Non-Examined refers to Section 5-219 of the Connecticut General Statutes which permits appointment of candidates to competitive positions without formal examination when a professional license, professional degree, accreditation or certificate is a mandatory requirement for appointment to a class.

Note: Applicants will be selected in accordance with reemployment, SEBAC, transfer, promotion, collective bargaining unit contract language, merit employment lists and DMHAS affirmative action goals. Therefore, State employees will generally be considered before applicants from outside State service.

Application Instructions: Due to the large number of lateral transfer forms and applications received, it is extremely important to note the **Position Number (found on the posting)** on the DMHAS Lateral Transfer Request Form (**upper right-hand corner**) and at the bottom of Page One of the State of Connecticut Application for Examination or Employment (CT-HR-12).

To be considered for this position:

1. **DMHAS employees who are lateral transfer candidates** (example: Staff Psychiatrist applying to a Staff Psychiatrist posting) must submit a completed DMHAS Lateral Transfer Form. Lateral Transfer Request Forms received without a position number will not be processed.
2. **All other applicants** must complete a State Employment Application for Examination and Employment (CT-HR-12). Resumes and Curriculum Vitae can be provided as supplemental information but will only be accepted if attached to a fully completed application.
