Eligibility Requirement: State employees currently holding the above title or those who have previously attained permanent status or candidates who possess the general and special experience and training may apply.

Duties may include but not limited to: Consistent with those within the Clinical Social Work Associate job specification. This position serves as a clinician in the Hartford Office of Forensic Evaluations. This position conducts evaluations on a team as well as independently in response to the following statutes: C.G.S. 54-56d, 17a-566, 171-694 and 17a-586. These evaluations take place in correctional facilities, hospitals, courts and in regional offices. There is a significant amount of report writing associated with this position and involves getting reports to court within a specified timeframe. This position also requires testimony in court on a regular basis. This position communicates directly with the courts and the Psychiatric Security Review Board as a function of his/her duties. This position reports directly to a Supervising Clinician within the Hartford Office of Forensic Evaluations. Statewide travel is required with use of their personal vehicle, mileage reimbursement is readily available for travel beyond the distance to the assigned office location in Hartford. This position requires that the work day may start in locations other than the office, such as in a correctional facility.

Special Requirement:

- Incumbents must possess and retain a current motor vehicle operator's license.
- Incumbents in this class must possess and retain a license to practice clinical social work pursuant to Sec. 20-195 (m) through (r) of the Connecticut General Statutes.
- Incumbents in this class are required to travel.
- Incumbents must pass a Department of Corrections background check.
