**Duties may include but not limited to:** Duties include but are not limited to: provision of clinical (prescriptive) services to various levels of care including but not limited to CSP/RP, medication management team, therapy teams, clinical (case management) teams, young adult services, etc. Provide initial psychiatric evaluation, ongoing mental status examination, ordering & review of medical tests, and the prescribing of appropriate medications consistent with client's diagnosis and symptom presentation. Provide individual, family and group counseling as needed. Will participate in collaboration of services with community providers as needed. Participate in education and training activities to be able to further professional development that relates to the programming needs of the agency. Candidate must comply with all mandatory trainings as per DMHAS or SWCMHS. Assist with programming choices based on a person centered choice and recovery approach. Candidate will be assigned to the Medical Services Unit and functional unit assignment will be subject to the needs of the agency. Incumbent is expected to participate in leadership roles at the F.S. Dubois Center as well as within SWCMHS/DMHAS. Must meet criteria for appointment to the SWCMHS medical staff and meet all requirements for the granting of clinical responsibilities/privileges as per the Medical Staff By-laws. Candidate is expected to provide primary clinical supervision & collaborate with agency psychiatric APRN. Candidate will serve as the primary chairperson of Critical Incident Reviews per SWCMHS medical director's assignment as needed.

**General Experience:** One (1) year of experience in a hospital, clinic or correctional facility as a staff psychiatrist.

**Special Requirement:** Travel may be required; off-site and on-site duties may be required. Must maintain active Connecticut licensure as Physician & Surgeon, must maintain active federal DEA registration, must maintain active Connecticut controlled substance registration and must be enrolled in Medicaid and Medicare as provider through the Department of Mental Health and Addictive Services and must maintain active CT driver's license. Bilingual (Spanish) skills are preferred. Candidate must be Board Certified in Psychiatry and maintain such certification as per the American Board of Psychiatry and Neurology. Candidate must serve as the collaborating physician for agency APRN as per DMHAS policy requiring APRNs to have a Collaborative Agreement signed and agreed to by the physician and the APRN (Proactive & Prescriptive Guidelines for Advanced Practice Registered Nurse/SWCMHS).

**Eligibility Requirement:** State employees currently holding the above title or those who have previously attained permanent status or candidates who possess the general and special experience and training may apply.

**Note:** Applicants will be selected in accordance with reemployment, SEBAC, transfer, promotion, collective bargaining unit contract language, merit employment lists and DMHAS affirmative action goals. Therefore, State employees will generally be considered before applicants from outside State service.
