Duties may include but are not limited to: Supervises the PSRB Monitor program; schedules, assigns, and oversees the work of staff; develops program goals and objectives; determines priorities and plans, coordinates and supervises program activities; develops performance standards and completes staff performance appraisals. Serves as a member of Whiting Forensic Division/Dutcher Service and Hospital risk assessment/risk management committees, collaborates with consulting forensic psychiatrists in monitoring and evaluating PSRB patients, provides consultation to inpatient treatment teams and other hospital staff; conducts interviews or evaluations of forensic patients, prepares and provides expert testimony before the Psychiatric Security Review Board (PSRB) and in State courts. Serves as liaison between the Whiting Forensic Division (WFD) and the Psychiatric Security Review Board, other operating units, attorneys, and external agencies and officials. Reviews/edits reports, applications, and other documents to be submitted to the PSRB; writes reports or prepares other documentation for the PSRB. Develops or assists with the development of policies, procedures, and standards for forensic services in the WFD. Provides in-service educational presentations to staff regarding forensic services and the PSRB. Performs related duties as required.

Eligibility Requirement: State employees who possess the general and special experience and training, currently hold the above title or those who have previously attained permanent status in the above title may apply.

General Experience and Training: A doctorate degree in clinical or counseling psychology and two (2) years of postdoctoral experience as a licensed clinical psychologist.

Special Requirements: Incumbents in this class must possess and retain a license to practice psychology in Connecticut. Any person employed by the State of Connecticut prior to July 1, 1985 with a title in the Psychology series of the classified service shall be exempt from the above licensure requirement pursuant to Public Act 613, Section 119(c). For certain positions the appointing authority may require state licensure.

Note: Applicants will be selected in accordance with reemployment, SEBAC, transfer, promotion, collective bargaining unit contract language, merit employment lists and DMHAS affirmative action goals. Therefore, State employees will generally be considered before applicants from outside State service.

Application Instructions:

Due to the large number of lateral transfer forms and applications received, it is extremely important to note the **Position Number (found on the posting)** on the DMHAS Lateral Transfer Request Form (**upper right-hand corner**) and at the bottom of Page One of the State of Connecticut Application for Examination or Employment (CT-HR-12)

To be considered for this position:

1. **DMHAS employees who are lateral transfer candidates** (example: Mental Health Assistant 1 applying to a Mental Health Assistant 1 posting) must submit a completed DMHAS Lateral Transfer Form. Lateral Transfer Request Forms received without a position number will not be processed
2. **DMHAS employees who are promotional/demotional candidates** must submit the State of Connecticut Application for Examination and Employment (CT-HR-12). The position number must be noted at the bottom of Page One of the State of Connecticut Application (CT-HR-12).
3. **All other applicants** must complete a State Employment Application for Examination and Employment (CT-HR-12). Resumes and Curriculum Vitae can be provided as supplemental information but will only be accepted if attached to a fully completed application.
