General Experience: Licensure as a Clinical Social Worker in the State of Connecticut

Duties may include but not limited to: provide best practice approaches to serve high risk/high need young adults in Lower County. The clinician will provide a full array of individual and group therapies including DBT, IDDT and TREM. This position will offer high level, sophisticated clinical services to support successful community living. Duties include providing clinical assessments for high risk/high need young adult clients including comprehensive data gathering; developing and evaluating individualized client-centered treatment plans; providing individual, group, and family psychotherapy and psycho-education to clients and families.

Special Requirements: Incumbents in this class must possess and retain a license to practice clinical social work pursuant to Sec. 20-195 (m) through (r) of the Connecticut General Statutes. Must possess and retain a current/valid Motor Vehicle Operator's License. May be required to travel.
