Position Description: The Connecticut Department of Transportation anticipates filling two (2) Transportation Planner 1 (TP1) positions (May be under filled as Connecticut Career Trainee (CCT) positions) in the Bureau of Policy and Planning, Water/Natural Resources unit at the DOT Administration Building in Newington, Connecticut. TP1 applicants must either be on the current TP1 exam list or hold the TP1 title and meet the qualifications below. These positions are full time; 40 hours per week and are open to the public. These positions are in the P-4 bargaining unit and require the possession of a valid Driver's License.

Duties in this unit include: the preparation and coordination of environmental permits and studies, conducting State and federal wetland delineations, preparing environmental permit applications, designing wetland mitigation sites, preparing monitoring reports, and coordinating with State and federal regulatory agencies.

***Applicants applying for the Trainee Program:** The CCT training program will be either one or two years (see Experience and Training Requirements section below). Upon successful completion of the CCT training program, the incumbent will be promoted to the target classification of Transportation Planner 1.

Preferred degrees include transportation or urban planning, civil engineering, environmental science, biology, geology, wetland ecology, soil science, geography or natural resource management. Other related disciplines that are deemed appropriate and relevant to these positions may also be considered. Interviews will be limited to those applicants whose education and skills most closely meet the requirements of each position.

MINIMUM QUALIFICATIONS REQUIRED:

KNOWLEDGE, SKILL AND ABILITY: Oral and written communication skills; ability to acquire knowledge and skills required for the target classification; ability to understand, evaluate and solve problems by exercising judgment and logic; ability to read, interpret and understand written material; ability to perform basic arithmetical computations; ability to interpret charts, graphs and tables; learning and reasoning ability; ability to establish and maintain cooperative relations with superiors, associates and general public; ability to utilize computer software.

Experience and Training Requirements:

2 year training program: Possession of a Bachelor's degree

1 year training program: Bachelor's degree plus a Master's Degree in civil engineering, transportation, urban, regional or environmental planning.

*The educational institution must be recognized by the CT Department of Higher Education as an accredited institution (www.chea.org). For foreign degrees not listed as accredited, documentation of equivalency from a recognized United States accrediting service must be submitted with your application package.
