Cady School at the Connecticut Juvenile Training School, Middletown, Connecticut. This is a durational (no benefits) full-time (35 hours per week) position. Qualified candidates must possess a valid CT Teaching Certificate, in Physical Education (044). Additionally, the ideal candidate will be resourceful, creative, have a working knowledge of the CT Curriculum Frameworks, strong classroom management skills, and a repertoire of varied individualized and small group instructional techniques. Experience in an educational program within a residential treatment facility and experience with a culturally diverse student population is preferred.

State employees currently holding the above title or those who have previously attained permanent status may apply for lateral transfer.

**Knowledge, Skills and Abilities:** Knowledge of the philosophy and methods of education and teaching; knowledge of the principles and practices of education for special needs population; knowledge of student program needs and goal setting; ability to motivate students; ability to communicate at the appropriate level; ability to establish cooperative relationships with those contacted in work; ability to prepare written reports.
