Eligibility Requirement:

Candidates must be on the current DAS exam certification list for the Environmental Analyst 1 job classification, OR for the Environmental Intern level, must have a Bachelor's or Master's degree in a scientific or technical discipline related to the environmental field. Current state employees who hold permanent status in the class of Environmental Analyst 1 may apply without taking the exam. Candidates on Reemployment/SEBAC list will be given first consideration.

Description of Duties: This position will be responsible for assisting with the technical review and analysis of environmental data, reports, and documents pertaining to the evaluation of impacts under the Connecticut Water Quality Standards and associated water management and water pollution control programs. Within the context of assessing and evaluating water quality conditions and related impacts, duties will include assisting with:

- Research, collection, and analysis of water quality related resource data;
- Conduct of site investigations and conditions;
- Review and analysis of proposed projects or actions;
- Assessment of impacts to exposed human and ecological populations;
- Preparation of recommended actions or alternatives to mitigate potential impacts;
- Technical consultations with various public and governmental officials;
- Preparation of publications, policies and guidelines; and
- Participation in public meetings.

Special Requirement: The incumbent may be exposed to some danger of injury or physical harm from onsite environments and a moderate degree of discomfort from exposure to year round weather conditions.

The preferred candidate will have experience or training in:

1. Biological or physical sciences, including environmental science, environmental geography, and/or biology;
2. Principles and practices of Geographic Information Systems, including ArcMap 9 or 10;
3. Coordinating effectively, work cooperatively, and contribute well in a team environment;
4. Evaluating and interpreting environmental data, determine potential environmental impact, and develop recommended actions;
5. State and federal water quality laws and pollution control programs, including the Clean Water Act, the Total Maximum Daily Loads, and Water Quality Standards;

6. Collecting and analyzing field data pertaining to the assessment of environmental conditions and health of ecological populations;
7. Software applications, including those designed to predict and analyze statistics and environmental data, including MS EXCEL, ACCESS, WORD, and PowerPoint, Minitab, and ProUCL;
8. Interpersonal, oral and written communication, and critical analysis skills, including writing technical reports and giving public presentations.

Note: The filling of this position will be in accordance with reemployment, SEBAC, transfer, promotion and merit employment rules, if applicable.
