PURPOSE OF CLASS: This class is accountable for independently performing a full range of tasks involved in installing, maintaining, testing, and repairing electronic and electro-mechanical equipment such as two-way radios, scientific electronic equipment, traffic signal equipment and other electronic devices.

MINIMUM QUALIFICATIONS REQUIRED

IN ORDER TO BE CONSIDERED FOR ADMITTANCE INTO THIS EXAMINATION, YOU MUST INDICATE ON YOUR APPLICATION THAT YOU HAVE THE FOLLOWING EXPERIENCE AND TRAINING BY FEBRUARY 10, 2015.

GENERAL EXPERIENCE: Four years of experience in the maintenance, repair and servicing of electronic equipment.

SUBSTITUTIONS ALLOWED: College training in electronics or a related field may be substituted for the General Experience on the basis of fifteen semester hours equaling one-half year of experience to a maximum of two years for an Associate's degree.

SPECIAL REQUIREMENTS: (1) Incumbents in this class may be required by the appointing authority to possess and retain appropriate current licenses, permits and/or certifications including possession of a license for the repair of radio equipment at time of appointment. (2) Incumbents in this class may be required to attend technical seminars or schools. (3) Incumbents in this class may be required to travel.

WORKING CONDITIONS: Incumbents in this class may be exposed to high voltage electricity; may be exposed to extreme weather conditions if required to work outside.

KNOWLEDGE, SKILLS AND ABILITIES (KSA's): Knowledge of the installation, maintenance, operation and repair of electronic equipment; knowledge of Federal Communications Commission rules and regulations where applicable; some interpersonal skills; some oral and written communication skills; ability to read and interpret instruction manuals and schematic and wiring diagrams; ability to install and operate electronic equipment; ability to locate and repair defects in electronic and electro-mechanical equipment and devices using analog, digital and logic functions; ability to utilize computer software.

APPLICATION PROCEDURE: In order to be considered for admittance into this examination, you must complete all parts of the examination application (CT-HR-12) detailing how you meet the minimum experience and training requirements stated above. Make certain your application form clearly details your employment history, including job titles, dates of employment and actual job duties as well as college degrees earned and current licenses and certifications. If faxing materials, keep a copy of your completed application form and exam materials and the fax transmittal receipt for your records. Make certain that your application form and exam materials are complete and transmitted correctly and without error. Incomplete faxes or faxes received blank because pages were faxed upside down will not be accepted. Due to the large number of applications received, we cannot confirm receipt of applications. Applications must be date stamped by DAS/Human Resources or postmarked by February 10, 2015. **A separate application form must be submitted for each exam you are applying for.**

FORMS: Application forms (CT-HR-12) and exam announcements are available from the Department of Administrative Services (<http://das.ct.gov/employment>) or at the Offices of the Connecticut State Job Centers.

NOTE: Applicants who applied for and passed the most recent examination for Electronics Technician 2 (examination #141481, promulgated in 2014) do not need to reapply. The lists from examination #141481 and examination #150092 will be consolidated.

(Applicants admitted to take the Electronics Technician 1 and Electronics Technician 2 examinations will only need to attend one examination session. You must apply for each examination separately if you wish to be considered for jobs in both titles. Reserve the day as the exam may be scheduled in the morning or afternoon.)
