**Eligibility Requirement:** State employees currently holding the above title or those who have previously attained permanent status may apply for lateral transfer.

Providing emergency medical care at the EMT-Intermediate level and providing routine ambulance transportation; provide fire suppression services, rescue, hazardous material incident responses and other emergencies as called for. Duties also include fire prevention activities including fire safety inspections and education activities to facility staff and clients. Perform other related duties as required.

#### **EXPERIENCE AND TRAINING**

**General Experience:** National certification by the National Board of Fire Service Professional Qualifications (NPQS) or the International Fire Services Accreditation Congress (IFACC) or State Certification by the Connecticut Fire Academy that meet the provisions of the National Fire Protection Association (NFPA) Firefighter 2.

**Substitution Allowed:** Successful completion of prescribed training and probationary requirements set forth in the class of Protective Services Trainee.

**Special Requirements:** Must possess and retain a valid Connecticut Class II Motor Vehicle Operator license. Will be required to obtain and maintain Emergency Medical Technician (Intermediate) certification.

**Physical Requirement:** Candidates must possess general good health; incumbents must possess and retain sufficient strength, stamina, agility and visual and auditory acuity necessary to perform all the duties of the class. Candidates will be required to pass a physical examination, including respiratory clearance.
