The University of Connecticut Health Center (UCHC) is seeking an experienced, dynamic project manager to manage the analysis, planning and implementation of upgrades and new projects associated with ICD 10 and ARRA HITECH Meaningful Use regulations. The position will be responsible for planning, coordinating and leading all aspects of these projects to meet organizational goals and timeframes. The ideal candidate would have strong large scale programs and project management experience with Clinical inpatient and outpatient systems, very strong planning skills, and be a self-motivated, dedicated leader able to quickly adapt to new concepts and directions. The position ensures that the project goals or objectives are accomplished and support compliance, efficiency, cost reduction and quality objectives.

**General Knowledge:** Demonstrated knowledge of ICD 10, ARRA HITECH Meaningful Use compliance regulations. Demonstrated project leadership skills, including strong experience with all project life cycle phases, including planning, analysis, specifications, quality assurance, process re-engineering, end user training, implementation and monitoring of compliance and metrics. Strong knowledge of healthcare and clinical systems. Proven ability to lead, manage and motivate cross functional teams challenged with multiple priorities; Demonstrated ability to manage and creatively solve problems impacting project progress; Ability to communicate project progress and issues at all levels, including presenting key highlights to senior executives. Demonstrates clear accountability for team performance and ownership of project results. Experience with vendor management, including creating RFPs, negotiation of contracts, financial monitoring and resource management.

**General Experience:** Eight (8) years experience managing multiple large scale Clinical system implementations with complex integration, data migration, reporting and data warehousing requirements, with special requirements as noted. Demonstrated experience with multiple clinical system implementations through all project life cycle phases, including planning, analysis, specifications, quality assurance, process re-engineering, end user training, implementation and monitoring of compliance and metrics.
