State employees currently holding the above title or those who have previously attained permanent status may apply for lateral transfer. Applicants will not have the opportunity to take the exam prior to the above closing date to qualify for this particular vacancy.

JAVA application developer needed to participate in ongoing maintenance and updates to application in an exciting and challenging law enforcement environment.
