Wappingwood is home to seven (7) medically fragile men and women. The LPN, under clinical supervision of the RN, provides direct nursing care including G-Tube, medical and respiratory treatments and medication administration. Provides assistance and training in all activities of daily living, including transportation using a large wheelchair accessible van. Acts as a shift charge, supervising DSW staff, responsible for health and safety of individuals living in the home through implementation of Residential Routine, Individual Plan Activities and programs, DDS Policies and Procedures. Current trainings related to DDS policy regulations are expected. Incumbents in this class must possess and retain a license as a licensed practical nurse in Connecticut. Must possess a valid driver's license. Must be certified in CPR, PMT and medication administration. Performs related duties as required.

EXPERIENCE & TRAINING

General Experience: Knowledge of practical nursing specialties and bedside care; knowledge of various medications used in conjunction with the physically and mentally handicapped; knowledge of infection control practices; some knowledge of nutrition and diets; basic knowledge of medical and lab sciences; considerable interpersonal skills; ability to keep records; some ability to lead staff. License or temporary permit to practice nursing in Connecticut by the State Board of Examiners for Nursing.
