Duties included but not limited to: Preventative maintenance tasks or minor repair on power tools or equipment, doors, windows, furniture, chairs, selective building systems or equipment. May do simple repairs to leaks on sinks or toilets, change air filters in air handlers, paint, patch walls, hang pictures/bulletin boards/shelves, move furniture. Clean grounds, shovel snow/dirt/stone, cut weeds/brush/shrubs/grass, clean sidewalks/driveways/storm sewers/catch basins, may perform preventative maintenance on grounds keeping equipment. May perform custodial duties as required, may assist in food preparation, serving, distribution of meals and cleaning of kitchen and kitchen equipment in food service area. Performs related duties in any of the areas that they are assigned.

Eligibility Requirement: State employees currently holding the above title or those who have previously attained permanent status may apply for lateral transfer.

Knowledge, Skills and Abilities: Some interpersonal skills; some oral and written communication skills; ability to follow oral and written instructions; ability to learn policies and procedures; ability to operate, care for and perform minor maintenance on tools and equipment used in daily work; some ability in simple record keeping.

Special Requirement: Incumbents in this class maybe required by appointing authority to possess and retain appropriate current licenses, permits and/or certifications. Must possess retain and carry valid Connecticut Driver's License. Travel is required.

Physical Requirement: Incumbents in this class must have adequate physical strength, stamina, and physical agility, visual and auditory acuity, and must maintain such physical fitness as to be able to perform the duties of the class. A physical examination may be required.

Working Conditions: Incumbents in this class may be required to lift moderate to heavy weights and may be exposed to extreme weather conditions and risk of injury from equipment and assaultive and/or abusive patients and/or clients.
