PURPOSE OF CLASS: In State facilities, this class is responsible for supervising a large crew of highly skilled trades workers and lower level employees in the maintenance and upkeep of grounds.

MINIMUM QUALIFICATIONS REQUIRED

THIS PROMOTIONAL EXAMINATION IS OPEN TO ANY CURRENT EMPLOYEE OF THE **DEPARTMENT OF DEVELOPMENTAL SERVICES** WHO BY **MAY 9, 2011** HAS PERMANENT STATUS IN THE CLASSIFIED SERVICE, SIX MONTHS SERVICE AT THE **DEPARTMENT OF DEVELOPMENTAL SERVICES** AND THE FOLLOWING EXPERIENCE AND TRAINING:*

GENERAL EXPERIENCE: Six years' experience in grounds maintenance.

SPECIAL EXPERIENCE: Four years of the General Experience must have been in grounds care in a lead or supervisory capacity. (For State employees, the Special Experience will be interpreted at or above the level of Skilled Maintainer.)

SPECIAL REQUIREMENTS: Incumbents in this class may be required to travel within the State in the course of their daily work. Incumbents in this class may be required by the appointing authority to possess appropriate current licenses or permits.

WORKING CONDITIONS: Incumbents in this class may be required to lift moderate to heavy weights; may be exposed to extreme weather conditions and to risk of injury from equipment. The appointing authority may require completion of an asbestos removal program consistent with EPA guidelines for operations and maintenance during employment in this class. Incumbents may be required to use protective equipment such as respirators and safety goggles.

PHYSICAL REQUIREMENTS: Incumbents in this class must have adequate physical strength, stamina, physical agility and visual and auditory acuity, and must maintain such physical fitness as to be able to perform the duties. A physical examination may be required.

KNOWLEDGE, SKILLS AND ABILITIES (KSA's): Considerable knowledge of modern methods and equipment involved in the maintenance and upkeep of grounds; considerable knowledge of relevant State and national codes and regulations; considerable interpersonal skills; considerable oral and written communication skills; skill in performing technical duties of the class; considerable ability to read and interpret specifications, blueprints, and sketches; supervisory ability.

Keep a copy of your completed application form and the fax transmittal receipt for your records. Incomplete faxes or faxes received blank because pages were faxed upside down will not be accepted. Due to the large number of applications received, we cannot confirm receipt of applications. **Applications must be date stamped by DAS/Human Resources or postmarked by May 9, 2011. A separate application form must be submitted for each exam you are applying for.**
