General Experience: General Experience: Incumbents in this class must possess and maintain licensure as a Physician Assistant issued by the Connecticut State Department of Public Health in accordance with the applicable Connecticut General Statutes.

Incumbents in this class must possess and maintain Connecticut Controlled Substance Registration for Practitioners issued by the State of Connecticut Department of Consumer Protection. 2. Incumbents in this class must possess and maintain United States Drug Enforcement Administration Registration issued by the United States Federal Government. 3.
