Duties include but are not limited to: This position is designed to provide best practice approaches to support young adults with severe and prolonged mental health and trauma-related conditions. These young adults are referred from hospitals, community-based settings and specialized DCF residential programs due to significant and complex risk issues. This position is critical in supporting the successful and safe transition of young adults from hospital levels of care to community-based settings. The Social Worker will provide a full array of individual and group therapies including: DBT, TREM, Seeking Safety, Janina Fisher model and IDDT. This position will offer high level, sophisticated clinical services to support successful community living. Duties include: individual and group therapy, clinical assessment, crisis intervention, life skill development, recovery planning, family support, monitoring, psycho-education to clients and families and clinical case management services. This individual will work as part of a team to develop and implement day programming which includes the following components: life skill development, community integration, peer supports, stress reduction, sophisticated clinical interventions both individual and group, safety planning, development of natural supports and leisure activities. This position may require on call administrative and clinical coverage during off hours to support the residential levels of care.

General Experience and Training: Licensure as a clinical social worker in the State of Connecticut.

Special Requirement: Incumbents in this class must possess and retain a license to practice clinical social work pursuant to Sec. 20-195 (m) through (r) of the Connecticut General Statutes. Must possess, retain and carry a valid Connecticut Drivers License. Travel in the community is required.

Note: The filling of this position will be in accordance with reemployment, SEBAC, transfer, promotion and merit employment rules, if applicable.
