**Duties include but are not limited to:** This position requires specialized clinical knowledge and skill to provide supervision, nursing coverage, leadership and direction to a multi-disciplinary team providing a full array of clinical services including outpatient and specialized residential services. The team is designed to provide state of the art, trauma-sensitive clinical services to young adults with complex and challenging mental health conditions. This position will also provide a full array of sophisticated clinical interventions to assist with safe and successful transitions from hospital levels of care and DCF placements to community settings. Duties include: clinical supervision, nursing, health screens for clients, training and staff development, individual and group therapy, clinical assessment, crisis intervention, life skills development, recovery planning and family support and close monitoring of clinical outcomes. This position may also require evening and weekend administrative on call coverage to provide clinical consultation and direction related to risk issues, clinical needs, staffing issues, critical incidents and overall program needs. This position may require evening and weekend hours depending on clinical needs of the program.

**General Experience and Training:** Four (4) years of experience as a professional nurse.

**Substitution allowed:** A Bachelor's degree in nursing may be substituted for one (1) year of the General Experience Master's degree in nursing may be substituted for one (1) additional year of the General Experience

**Special Experience** Two (2) years of the General Experience must have been in a psychiatric setting in supervised individual, group and/or family therapy.

**Special requirements:** Incumbents in this class may be required to travel. Incumbents in this class may be required to possess and retain a valid Motor Vehicle Operator's License. Within the Department of Mental Health and Addiction Services, incumbents in this class who write medications must have a current license as an Advanced Practice Registered Nurse issued by the Department of Health. Incumbents in this class must possess and retain a current license as a registered professional nurse in Connecticut.
