The Department of Children and Families currently has a vacancy for a Rehabilitation Therapy Assistant 2 at the Albert J. Solnit Children's Center South Campus in Middletown, CT (formerly Riverview Hospital). This is a part-time (34 hours per week), 2nd shift position. Responsibilities include but are not limited to implementing therapeutic recreation activities; assists in planning rehabilitation programs to improve client functioning and address client treatment needs; observes, reports and charts client behavior and responses; prepares records and reports; participates in interdisciplinary treatment teams; maintains equipment and supplies, may prepare treatment plans and screen clients under supervision of a professional therapist and perform related duties as required. Experience and Training:

General Experience: three years of experience working with patients and/or clients exhibiting mental, emotional, or motor status disorders required.

Special Experience: one year of the general experience must have been at the level of Rehabilitation Therapy Assistant 1 or its equivalent.

Substitutions: an Associate's Degree in a recognized therapeutic discipline may be substituted for the General and Special Experience.
