Facilitates connections to the client's community recovery supports. Provides services that are highly individualized and tailored to the needs and preferences of the individual. Participates with clients in the development of a comprehensive functional assessment that will assist clients in learning skills that are applicable to their environment. Provide timely service documentation related to progress towards client goals and objectives.
