**PURPOSE OF CLASS:** In a state facility this class is accountable for the evaluation, planning and application of professional music rehabilitation therapy programs to provide treatment for persons with mental, emotional and physical disabilities.

**MINIMUM QUALIFICATIONS REQUIRED**

IN ORDER TO BE CONSIDERED FOR ADMITTANCE INTO THIS EXAMINATION, YOU MUST INDICATE ON YOUR APPLICATION THAT YOU HAVE THE FOLLOWING EXPERIENCE AND TRAINING BY **NOVEMBER 7, 2013**.

**GENERAL EXPERIENCE:** Four years of professional experience in a professional music rehabilitation therapy program performing such activities as program evaluation, planning and application for persons with mental, emotional and physical disabilities.

**SUBSTITUTION ALLOWED:** College training in music rehabilitation therapy may be substituted for the General Experience on the basis of fifteen semester hours equalling one-half year of experience to a maximum of four years for a Bachelor's degree.

**SPECIAL REQUIREMENTS:** (1) Incumbents in this class may be required to possess and maintain a certificate as a Water Safety Instructor (W.S.I.), and/or life saving (CPR, First Aid) from the American Red Cross. (2) Incumbents in this class may be required to be fluent in a foreign language or proficient in use of American sign language in certain positions. (3) Incumbents in this class may be required to travel.

**WORKING CONDITIONS:** Incumbents in this class may be exposed to some danger of injury and to moderately disagreeable job conditions while providing treatment to persons with disabilities.

**KNOWLEDGE, SKILLS AND ABILITIES:** Knowledge of principles and practices of music rehabilitation therapy; knowledge of physical, mental and psychosocial disorders; knowledge of individual and group dynamics; considerable interpersonal skills; oral and written communication skills; skill in application of therapeutic techniques.

Incomplete faxes or faxes received blank because pages were faxed upside down will not be accepted.** Due to the large number of applications received, we cannot confirm receipt of applications. **Examination scores will be mailed by December 18, 2013. A separate application form must be submitted for each exam you are applying for.**
