EXAMPLES OF DUTIES

The SDSW will be responsible for providing care and supervision to five individuals who reside at 67 Mountain Road, an ICF home. Clients have challenging behaviors including PICA. The incumbent must be able to write and implement teaching strategies and active treatment schedules. Additionally, they must be able to provide for the health and safety of the residents. The SDSW must possess strong supervisory and interpersonal skills and is responsible for supervising all staff in the home. SDSW is required to attend IDT meetings, complete staff orientation and in servicing of staff. The SDSW must have knowledge of scheduling, overtime distribution, and management of client and agency funds. Experience with psychiatric population is preferred. Must possess valid driver's license. Must be current in CPR and PMT. Performs related duties as required.

EXPERIENCE & TRAINING

General Experience: One (1) year's experience working with persons with mental retardation or other developmental disabilities at the level of Developmental Services Worker 2.

Special Requirements: 1. Incumbents in this class may be required to be bilingual or fluent in American Sign Language.
