Eligibility Requirement: State employees currently holding the above title or those who have previously attained permanent status may apply for lateral transfer. Those candidates appearing on Re-employment or SEBAC lists must be given first consideration.

Knowledge, Skills and Abilities: Duties consistent with the Skilled Maintainer job specification. Accountable for performing one or more tasks of a skilled nature in one or several of the following areas: Building and equipment maintenance, (operational and remedial), including the operation of trucks of 5 ton or greater capacity or complex motorized equipment. Incumbent will also be responsible for vehicle upkeep via Department of Administrative Services (DAS) State of Connecticut Fleet Operations; supervision of Grounds care; Maintaining / updating Preventive Maintenance Logs; Data entry and retrieval of LAN Regional automated work order system (E-Maintenance); PR formulations, and receivers for related Maintenance material acquisitions; Assist Qualified Craft Workers or other higher level employees in the trades areas. Performs other related duties

General Experience: Two (2) years experience in one of the following areas: (1) one of the skilled trades, (2) Landscape maintenance or vegetable gardening, (3) Operation of motor trucks or large buses.

Special Experience: Prior training below the level of specialized trade's worker. Considerable knowledge of methods, tools, equipment, materials and procedures of specific trade or work area; knowledge of maintenance problems and their proper resolution; skill in manual and machine operations of trade or work area.

Special Requirements: Good oral and written communication skills. Must have valid Connecticut driver's license.

Physical Requirement: Incumbents in this class must have adequate physical strength, stamina, physical agility and visual and auditory acuity and must maintain such physical fitness as to be able to perform the duties. A physical examination may be required.
