PURPOSE OF CLASS: In the Department of Emergency Services and Public Protection, Division of State Police, this class is accountable for administrating major field, staff or support bureau operations.

MINIMUM QUALIFICATIONS REQUIRED

THIS **AGENCY PROMOTIONAL EXAMINATION** IS OPEN TO ANY **CURRENT** EMPLOYEE OF THE **DEPARTMENT OF EMERGENCY SERVICES & PUBLIC PROTECTION** WHO BY **JUNE 10, 2016** HAS PERMANENT STATE STATUS*, SIX MONTHS SERVICE IN THE **DEPARTMENT OF EMERGENCY SERVICES & PUBLIC PROTECTION**, AND THE FOLLOWING EXPERIENCE AND TRAINING:

GENERAL EXPERIENCE: Three years of experience as a State Police Lieutenant or above.

SPECIAL REQUIREMENTS: Incumbents in this class must possess and retain a valid Connecticut Motor Vehicle Operator license.

PHYSICAL REQUIREMENTS: Incumbents in this class must possess sufficient strength, stamina, agility and endurance to perform all the duties of the class.

KNOWLEDGE, SKILLS AND ABILITIES: Considerable knowledge of and ability to apply management principles and techniques; considerable knowledge of relevant agency policies and procedures; considerable knowledge of relevant state and federal laws, statutes, regulations and court decisions; considerable knowledge of principles of modern police administration, organization and management; considerable knowledge of modern police investigative techniques, procedures and aids; considerable interpersonal skills; considerable oral and written.

APPLICATION/EXAMINATION INSTRUCTIONS: In order to be considered for admittance into this examination, you must complete all parts of the examination application (CT-HR-12) detailing how you meet the minimum experience and training requirements stated above. Make certain your application form clearly details your employment history, including job titles, dates of employment and actual job duties as well as college degrees earned and current licenses and certifications. **THIS MATERIAL WILL CONSTITUTE THE EXAMINATION FOR THIS CLASS. This examination will be scored as pass/fail. Candidates receiving a "pass" will be subject to a follow up oral interview conducted by the agency.** In order to be considered for this examination, your completed application form must be date stamped by DAS/Human Resources or postmarked by **JUNE 10, 2016**. Mail your application to DAS/Human Resources, Room 404, State Office Building, 165 Capitol Avenue, Hartford, CT 06106-1658 (**Secure Fax #860-622-2910 – preferred method of receipt**). **If faxing materials, keep a copy of your completed application form and exam materials and the fax transmittal receipt for your records. Make certain that your application form and exam materials are complete and transmitted correctly and without error. Incomplete faxes or faxes received blank because pages were faxed upside down will not be accepted.** Due to the large number of applications received, we cannot confirm receipt of applications. **Examination scores will be mailed by JULY 14, 2016. A separate application form must be submitted for each exam you are applying for.**
