**Duties may include but not limited to:** Provides direct administrative and clinical supervision to the Clinical Social Worker Associate of Young Adult Services (YAS) Transitional Housing Program. Provides administrative supervision to Head Nurses of the Young Adult Program and provides clinical supervision to YAS contracted community supportive housing providers. Works in collaboration with WCMHN Recovery and Wellness program to ensure ongoing course/group development to YAS population. Assist in the development of staff working in the 24 hour YAS program. Develops relationships with community providers to ensure integration of services to young adult clients. Identifies barriers and assists with strategies and solutions to improving client care.

**To be considered for this position, candidates must possess the general and special experience and special requirements:**

**General Experience:** Seven (7) years of professional health care experience in a psychiatric setting.

**Special Experience:** Two (2) years of the General Experience must have been at a lead level responsible for coordinating the work of a unit or team of professionals in a psychiatric setting. **Note:** For State Employees the lead level is interpreted at the level of a Clinical Social Worker Associate for social work discipline.

**Substitutions allowed:** College training may be substituted for the General Experience on the basis of fifteen (15) semester hours equaling one-half (1/2) year of experience to a maximum of four (4) years for a Bachelor's degree. A Master's Degree in a health care field related to the discipline in the Special Experience may be substituted for one (1) additional year of the General Experience.

**Special Requirements:**

- Incumbents in this class **must possess and retain** a license to practice clinical social work pursuant to Sec. 20-195 (m) through (r) of the Connecticut General Statutes.
- Incumbents **must possess and retain** a current/valid motor vehicle operator's license. Incumbents in this class may be required to travel.

**Note:** Applicants will be selected in accordance with reemployment, SEBAC, transfer, promotion, collective bargaining unit contract language, merit employment lists and DMHAS affirmative action goals. Therefore, State employees will generally be considered before applicants from outside State service.

**Application Instructions:**

**To be considered for this position:**

1. **DMHAS employees who are lateral transfer candidates** (Example Supervising Clinician applying to Supervising Clinician posting) must submit a completed DMHAS Lateral Transfer Form. Lateral Transfer Request Forms received without a position number will not be processed.
2. **DMHAS employees who are promotion/demotion candidates** must submit the State of Connecticut Application for Examination and Employment (CT-HR-12). The position number must be noted at the bottom of Page One of the State of Connecticut Application (CT-HR-12).
3. **ALL OTHER APPLICANTS** who meet the General and Special Experience and the Special Requirements must complete a State Employment Application for Examination and Employment (**CT-HR-12**). Resumes and Curriculum Vitae can be provided as supplemental information but will only be accepted if attached to a fully completed application.
