[Transportation Engineer Trainee](#) positions are the Department of Transportation’s entry level engineering positions.

**Eligibility:** These positions are open to candidates who possess a Bachelor’s degree in engineering or construction management (“Substitutions Allowed” are listed on the class specification). Other minimum qualifications for this position are a general knowledge of basic transportation engineering theories, principles and methods; skill in use of computer aided design software and other computer applications; considerable ability in performing mathematical computations, making neat and accurate drawings and preparing minor design and structural details. A valid driver’s license may be required.

Positions are available at our Newington, Connecticut Headquarters and at other DOT locations throughout the State of Connecticut. Although positions may become available throughout the Department, positions are more frequently available in Highway Design, Bridge Design, Traffic Engineering, and Construction.

Candidates who are appointed to this classification receive training in introductory professional engineering work for the development of technical and professional engineering skills and knowledge, in order to qualify for advancement to the technical engineering work of the Department.

Candidates are eligible for promotion to [Transportation Engineer 1](#) after successful completion of the two (2) year training program. Candidates who meet the minimum qualifications of [Transportation Engineer 1](#) or [Transportation Engineer 2](#) before the end of the training program may be considered for early promotion.

**Application Instructions:** To apply, submit a cover letter which clearly states your interest and suitability for the position, a resume and a [State application form \(CT-HR-12\)](#) to [dot.recruiting@ct.gov](mailto:dot.recruiting@ct.gov). Be sure to include any relevant information such as any engineering specialization or concentration in college, relevant internships or coursework, or area of engineering that is of special interest.

***Students who expect to graduate with a Bachelor’s degree in Engineering or Construction Management within the next six months are encouraged to apply.***

Applications for Transportation Engineer Trainee are accepted on an ongoing basis and are retained for one year. Applications are reviewed as positions are approved to fill. Interviews are limited to candidates whose experience and training most closely meet the requirements of the positions.

**Note:** The filling of positions will be in accordance with State of Connecticut reemployment, SEBAC, transfer, promotion and merit employment rules, if applicable.
