**PURPOSE OF CLASS:** In the Department of Transportation, this class is accountable for supervising a maintenance and repair garage for automotive and highway maintenance equipment.

**MINIMUM QUALIFICATIONS REQUIRED**

THIS PROMOTIONAL EXAMINATION IS OPEN TO ANY **CURRENT** EMPLOYEE OF THE **DEPARTMENT OF TRANSPORTATION** WHO BY APRIL 27, 2012 HAS PERMANENT STATUS IN THE CLASSIFIED SERVICE\*, SIX MONTHS SERVICE AT THE **DEPARTMENT OF TRANSPORTATION** AND THE FOLLOWING EXPERIENCE AND TRAINING:

**GENERAL EXPERIENCE:** Five years' experience in the repair and maintenance of automotive and highway maintenance equipment.

**SPECIAL REQUIREMENTS:** One year of the General Experience must have been as a highly skilled mechanic. [Note: For State employees, the Special Experience will be interpreted at or above the level of Qualified Craft Worker (Automotive and Mechanical Equipment) or Department of Transportation Maintainer 4.]

**SUBSTITUTION ALLOWED:** Graduation from a vocational or technical school with a diploma designating completion of the subject requirements in automotive repair may be substituted for two years of the General Experience.

**SPECIAL REQUIREMENT:** The appointing authority may require the possession of appropriate current licenses or permits during employment in this class.

**PHYSICAL REQUIREMENT:** Employees appointed to positions in this class must have adequate physical strength, stamina, physical agility and visual and auditory acuity, and must maintain such physical fitness as to be able to perform the duties. A physical examination may be required.

**WORKING CONDITIONS:** Incumbents may be required to lift; may be exposed to some risk of injury from equipment.

**KNOWLEDGE, SKILLS AND ABILITIES (KSA's):** Considerable knowledge of and ability to diagnose motor and equipment problems and to use complicated testing equipment and welding devices; knowledge of record keeping and inventory procedures; interpersonal skills; oral and written communication skills; skill in operation, repair and maintenance of automotive and highway maintenance equipment; supervisory ability.

**APPLICATION PROCEDURE:** In order to be considered for admittance into this examination, you must complete all parts of the examination application (CT-HR-12) detailing how you meet the minimum experience and training requirements stated above. Make certain your application form clearly details your employment history, including job titles, dates of employment and actual job duties as well as college degrees earned and current licenses and certifications. If faxing materials, keep a copy of your completed application form and the fax transmittal receipt for your records. Make certain that your application form is complete and transmitted correctly and without error. Incomplete faxes or faxes received blank because pages were faxed upside down will not be accepted. Due to the large number of applications received, we cannot confirm receipt of applications. Applications must be date stamped by DAS/Human Resources or postmarked by April 27, 2012. **A separate application form must be submitted for each exam you are applying for.**
