STATE MARSHAL COMMISSION MEETING
June 23, 2016

Members present: Chairperson W. Martyn Philpot, Jr., Esq., Sarah Fryxell, Esq. (via teleconference call), Robert P. LaTorraca (via teleconference call), Mildred Torres-Ferguson (via teleconference call), Tracy L. Dayton, Esq. (via teleconference call), and Michael Desmond. Commissioner LaTorraca was present starting just prior to the vote to enter executive session. Also present were Ex-Officios Lisa Stevenson and Thomas Burke (non-voting members), Staff Director Jeffrey Beckham and Staff Attorney Jennifer Y. Montgomery. Vice Chairperson Michael Cronin, Esq. and Honorable Elizabeth A. Bozzuto were not present.

Chairperson W. Martyn Philpot, Jr., Esq. called the meeting to order at 4:46 p.m.

First Business

1. Minutes

Old Business

2. Update Richard Grimaldi Request

Jeffrey Beckham provided an update regarding Richard Grimaldi's request for training. He advised that, pursuant to the Commission's request at the May meeting, he contacted Attorney Owen Eagen who had provided the previous training. He indicated that he would be willing to provide training to Mr. Grimaldi at the Commission's pleasure. He is not available until the fall. Attorney Eagen indicated that he would expect to be compensated and mentioned that he would consider offering a discount. Attorney Beckham and Attorney Eagen did not discuss numbers. W. Martyn Philpot, Jr., Esq. suggested that, in light of DAS Commissioner Currey's letter to the Commissioners regarding this issue, Mr. Grimaldi's training would be appropriately conducted during the next scheduled training for new marshal appointees.

3. Training

Jeffrey Beckham provided an update regarding the pending capias training being held at Manchester Community College. DAS provided \$14,000 for the mandatory capias training which is held every three years. The training this year included a new module provided by Child Support Enforcement which gave significant insight into how the Judicial Branch operates. Attorney Beckham advised that the Commission office looks forward to facilitating ongoing meetings between the marshals and the Judicial Branch.
